 The Defendant is ordered to complete the Victim Impact Panel within 60 days of the date of this order.  
 None of the above;
4. The Clerk's Office is hereby directed to submit a supplemental disposition report concerning this action to the Department of Highway Safety and Motor Vehicles, Bureau of Driver's Licenses.
